Pet Visit Policy Form

Pet Visits (in your home):

How it Works

- Each pet visit is set at 20 minutes and is in the comfort of pets' home environment. These visits can be booked as often as you feel necessary to assure your pet is kept on his/her same daily routine. The 20 minute time slot will allow for a walk/time(10-15min), filling water/feeding, medication(NO INJECTIONS), and love and attention before I leave, all at owners preference and discretion. (Each visit varies by the owners requests)
- Cat and small animal visits include scooping and changing litter as needed, small animal cages scooped and light cleaning as needed, feeding, fresh water, medicating at owners request (NO INJECTIONS), treats and playtime if applicable.
- Pet walks may be shortened due to inclement weather, extreme heat, or dogs' motivation. If our walk is cut short, the remainder of the visit will be held inside.
- At owners request, lights will be altered, mail brought in etc.
- All pet visits will have a 1-hour window. For example, if needing a 12pm visit, the time window will either be 11am-12pm or 12pm-1pm. This is based on scheduling needs and travel time.
- If pet shows signs of illness, owner will be notified immediately, no matter the time of day/night. If owner cannot be reached, I will contact the listed emergency contact documented. If emergency contact cannot be reached, I will transport your pet to the Primary Vet listed on form, or the Emergency Vet (depending on time of day). **THE OWNER WILL BE HELD FULLY RESPONSIBLE FOR BILL PLUS \$25 TRANSPORT FEE.**
- After returning home safely to your pets, please contact me to let me know you are home with your pet and no further visits will be needed. A text or phone call are the best methods to reach me: (908) 433-5250.

Charges

- Each pet visit starts at \$18/visit for dogs and \$20/visit for cats and small animals.
- Rate includes up to two pets, there is a \$2 additional charge for each pet after those two.
- There is a \$3 additional charge for administering medication and supplements (at owners request). **NO INJECTIONS.** All bottles/tubes need to have pet name, veterinarian, dosage information, and signed pet form by owner.
- There is an additional charge of \$1 per mile exceeding the first 10 miles included from home office location in Wanamassa (07712).
- **Holiday rate:** there will be an additional charge of \$10 per DAY for holidays including New Years Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas Eve, Christmas, and New Years Eve.

Extended Visits:

All added time to your pets' visits are welcome (when available), and I will try my best to accommodate everyone that I can.

- There is a \$5 up-charge for every additional 10 minutes added to pet visit at owners request.

Hours

Normal visit hours are between 8am and 9pm. Before/After hours are all visits booked before 8am or after 9pm. There is an additional \$2 charge for each before/after hours visit.

- There is a \$30 returned check fee.

Vaccinations:

Pets can be exposed to many different infectious diseases, even while just out on a walk. All pets must be up-to-date on the following vaccinations:

- Rabies
- Bordetella (kennel cough)
Bordetella (kennel cough) is a highly transmitted upper respiratory illness and is airborne. It is spread through direct and or close contact with an infected pet by droplet transmission or contaminated surface.

Disclaimer: Pamper Me Pets is only responsible for the care of the pet and home while present during visit. Pamper Me Pets is not responsible for pets or home in between pet visit. Please pet proof your home prior. Please make sure medication bottles are out of reach. Pamper Me Pets asks that the owner does NOT leave any bones, or rawhides for animals while away. These pose a dangerous risk when left unsupervised.
